Brief Statement of Accident: Unit1 was traveling Eastbound on Alexis. As it approached the intersection of Yermo Unit2 failed to yield to oncoming traffic and pulled into the path of Unit1. Unit1 struck Unit2. After the collision Unit1 continued Eastbound on Alexis where it struck a curb and then a utility pole before coming to rest. After the collision Unit2 spun at least once to where the rear end of the vehicle struck the Northern curb of Alexis road. Unit2 then spun an addition 180 degrees before coming to rest between the road and the sidewalk on the North side of Alexis road. While Unit2 was spinning the front seat passenger, Leilanie Allen, was ejected from the vehicle. All persons inside of Unit1 were transported to Saint Ann with minor injuries. Both persons inside of Unit2 were transported to Toledo Hospital. The drive, Bryan Ballard, of Unit2 sustained life threatening injuries and was in critial condition. Allen sustained serious but not life threatening injuries and was in stable condition.
