Brief Statement of Accident: Mr. Cieply was parked in a work truck on Edgewater at 131. Mr. White was traveling northbound on Edgewater Dr. approaching 131 on a Yamaha 3-wheel ATV. Mr. White attempted to go around the work truck as Mr. Patterson was turning from eastbound 131 to southbound Edgewater in a Ford F-150. Mr. White then took evasive maneuvers by turning sharply right. Mr. White then collided with the front of the work truck.
