Brief Statement of Accident: JAMAL HOLMES WAS TRAVELING NORTH ON COLLINGWOOD AT I475 IN THE CURB LANE. TRAFFIC WAS STOPPED FOR A RED LIGHT. THE CURB LANE HAD NO STOPPED TRAFFIC IN IT. MARIANNA HOOKER WAS ON HER BICYCLE WITH A FRIEND APPROACHING THE TRAFFIC LIGHT AT COLLINGWOOD AND 475 NORTH BOUND. AS HOOKER ENTERED THE TRAFFIC WAY, THE TRAFFIC LIGHT TURNED GREEN. AT THE SAME TIME HOOKER HAD ENTERED THE TRAFFIC WAY, HOLMES BEGAN TO SPEED UP. WHEN HOOKER ENTERED HOLMES TRAFFIC WAY, SHE WAS STRUCK.
