Brief Statement of Accident: Toledo Police Officers were dispatched to the intersection of South and Spencer on a serious injury accident. Upon arrival officers found a dirt bike vs SUV. An accident investigator was sent to the scene to assist, the accident investigator concluded the following: Mr. Hallauer was traveling east on South Ave on a non-registered dirt bike at a high rate of speed. Ms. Bouyer was traveling south on Spencer and continuing through the intersection at Spencer and South. Mr. Hallauer was unable to slow down in time and collided with Ms. Boyer, ejecting Mr. Hallauer from the dirt bike causing serious injury. Mr. Hallauer was transported to St. Vincent Hospital, at this time the investigation continues.
