Brief Statement of Accident: UNITS #1, #2 AND #3 WERE ALL N/B ON SECOR TOWARDS LASKEY. A LARGE TREE IN FRONT OF 4832 SECOR FELL INTO THE ROADWAY ONTO SECOR AND ON TOP OF UNIT #1 CAUSING MASSIVE DAMAGE TO UNIT #1. OPERATOR OF #1 WAS INJURED AND TAKEN TO TOLEDO HOSPITAL FOR TREATMENT. PASSENGER OF UNIT #1 WAS PRONOUNCED DECEASED AT THE SCENE BY TFD.

UNITS #2 AND #3 WERE ALSO N/B AT THE TIME OF INCIDENT AND BOTH SUFFERED DAMAGE TO THEIR AUTOS AS A RESULT OF THE TREE FALLING INTO THE ROADWAY BUT NO INJURIES TO OCCUPANTS.
