Brief Statement of Accident: Unit #1 was EB on Spencer, turned left into a drive-way. #1 backed out of the drive-way as Unit #2 was WB on Spencer, and #2 struck #1 in the rear. Unit #2 was thrown from the motorcycle and seriously injured with multiple broken bones and multiple laceration to his entire body. TFD #21 and #9 responded to the scene and treated unit #2. unit #2 was transported to UTMC by TFD Medic #9. Both witnesses (were sitting on the porch of 672 Spencer) stated that the Blk truck pulled into the drive-way and backed out into the motorcycle that was WB on Spencer. Witnessed states the motorcycle was not speeding(appr. 30 MPH). Both vehicle were towed from the scene. Investigation continues...
