Every summer the Toledo Police Department sponsors the **Safe-T-City** Program at no cost. This program is held at the Scott Park Shelter House, 2301 Nebraska Avenue, next to the Scott Park Police District Station.

Safe-T-City is a child pedestrian and traffic safety program combined with a life safety course. **This program is conducted for children entering KINDERGARTEN in the upcoming school year. All students must be fully potty-trained to attend this program.** **Safe-T-City** includes classroom instruction and outdoor practice in a miniature city complete with streets, sidewalks, small buildings, traffic lights and stop signs.

The children are assigned to classes (no more than 12 children per class) with a certified instructor. During the 20-hour course, the children learn through participation in a setting of simulated real-life situations. Guest speakers from different community resources help the children learn through songs, poems, art projects, stories and movies. Police officers teach pedestrian safety on the streets of **Safe-T-City**. The different lessons provide an enjoyable learning experience.

We also have a program for developmentally-delayed children and those children with special needs. This program is for children in kindergarten through third grade.
