Brief Statement of Accident: On listed date and time Vehicle 2 was stopped at a red light facing Westbound on Phillips at I75, when Vehicle 1 failed to maintain an assured clear distance and rear ended the motorcycle. The motorcycle fell over and caused what was believed to be serious injury to Baldwin. Baldwin was transported to an area hospital where it was determined that her injuries were minor.
