Brief Statement of Accident: ON 7-4-25 AT 1832 HOURS IN THE 3800 BLOCK OF AIRPORT HWY A SERIOUS INJURY ACCIDENT OCCURRED. UNIT#1 WAS HEADED WESTBOUND ON AIRPORT HWY IN THE 3800 BLOCK. UNIT#2 WAS HEADED EASTBOUND ON AIRPORT HWY IN THE 3800 BLOCK. IT APPEARED THAT UNIT#1 CROSSED THE CENTER LINE AND THE TWO UNITS COLLIDED CAUSING AN ACCIDENT. THE DRIVER AND PASSENGER OF UNIT#1 WERE INJURED AND TRANSPORTED TO UPMC HOSPITAL. THE DRIVER OF UNIT#2 WAS EJECTED AND WAS PRONOUNCED DECEASED ON SCENE BY TOLEDO FIRE PERSONNEL. THE ACCIDENT INVESTIGATION CONTINUES.
