Brief Statement of Accident: ON 7-7-25 AT 0253 HOURS AT CHERRY ST AND N SUMMIT ST A FATAL ACCIDENT OCCURRED. UNIT#1 (TOW TRUCK) WAS HEADED NORTHWEST ON CHERRY ST APPROACHING N SUMMIT ST IN THE RIGHT STRAIGHT LANE WITH A SOLID GREEN LIGHT. UNIT#2 (MOTORIZED SCOOTER) WAS HEADED NORTHEAST ON N SUMMIT ST APPROACHING CHERRY ST IN THE RIGHT STRAIGHT LANE WITH A SOLID RED LIGHT. UNIT#1 BEGAN TO ENTER THE INTERSECTION THROUGH THE GREEN LIGHT. UNIT#2 ENTERED THE INTERSECTION INTO THE PATH OF UNIT#1 THROUGH THE RED LIGHT. UNIT#1 STRUCK UNIT#2 CAUSING AN ACCIDENT. THE DRIVER OF UNIT#1 WAS NOT INJURED. THE DRIVER OF UNIT#2 WAS EJECTED AND WAS PRONOUNCED DECEASED AT THE SCENE BY TOLEDO FIRE UNIT MEDIC 3 AT 0259 HOURS. THE ACCIDENT INVESTIGATION CONTINUES.
