Brief Statement of Accident: Unit 01 was traveling on Jackman Rd. heading south in a red Chevy Cruze approaching Central Ave. Unit 01 driven by Promisee Williams intended to make a right turn to head west on Central Ave. When Unit 01 reached the intersection to make the right turn, for unknown reasons failed to navigate the right turn and went off the road to the left over a curb on to a concrete island. Unit 01 continued on the concrete island and struck the steel traffic light pole and came to rest. All occupants of Unit 01 were transported to the hospital for treatment. The driver's side rear passenger, Nadia, suffered critical injuries during the collision.
