Brief Statement of Accident: On listed date and time Murray was operating a Jeep Westbound Glendale when he went left of center and sideswiped an Eastbound Ford, and then sideswiped an Eastbound Toyota, that had struck an Eastbound Corvette as the Toyota attempted to make an evasive maneuver. The Toyota overturned and the passenger of the Toyota Rys suffered a serious non life threatening injury to his hand and was transported to a hospital for treatment. No other injuries were reported.
